## History

- The Protection and Advocacy concept was initially triggered by a series of local television news broadcasts, which Geraldo Rivera did for the ABC News affiliate in New York City. Rivera's investigative reporting exposed abuse, neglect, and lack of programming at Willowbrook, a state institution for people with intellectual disabilities on Staten Island.

## Kentucky P&A

- Currently (6/20/22), KY P&A is an 18-employee state agency, housed within the Department of Public Advocacy. Our main office is in Frankfort.
- We are a law practice that has both attorneys and non-attorney advocates. All non-attorney advocates are supervised by an attorney.
- Like most of you, we serve the entire Commonwealth of Kentucky.
- We serve individuals of all ages and disabilities who reside within the community or in institutions.



To protect and promote the rights of Kentuckians with disabilities through legally-based, individual, and systemic advocacy and education.

### Values

- Kentuckians with disabilities have a right to self-determination including, but not limited to, the right to refuse, the right to participate, and the right to choose.
- Kentuckians with disabilities have the same inherent rights as Kentuckians without disabilities.
- Kentuckians with disabilities will live and receive services in integrated and inclusive settings.
- Kentucky Protection and Advocacy values and accepts differences and diversity.

#### KY P&A Service Provision

- Anyone with a disability-related question may contact P&A.
- The person with a disability doesn't have to be drawing disability benefits or a U.S. citizen
- All services are free, regardless of income.

#### KY P&A is Client Directed

Even with minors, the child is the client

Example at an ARC Meeting:

Parent: "I want Johnny to use his FM system every day."

Johnny: "I don't want to wear an FM system."

Advocacy effort go toward getting what Johnny – not his parents – want.

#### KY P&A's Call Response Process

- 1. An information & referral (I&R) request is made to P&A (phone call, email, etc.)
- 2. Request is assigned to an advocate or an attorney
- 3. The assigned P&A staffer responds to referral source within 3 business days.
- 4. Depending on particulars of the situation, call would either stay as an I&R or become a case

#### Case Acceptance

- Based on our priorities developed yearly with public input.
- If the situation can happen to anyone (with or without a disability), then it IS NOT considered to be disability-related.

# KY P&A for Transition-Age Youth

#### Abuse Hurts at Any Age!

The Department for Community Based Services (DCBS) are the frontline investigators.

KY P&A can do abuse/neglect investigations that involve disabilityservice providers and facilities.
